

Criminal Business at Dumbarton Sheriff Court

from 25th March 2020 to 09th April 2020

The Court will pronounce refixing diets in terms of Section 137ZB (2) of the Criminal Procedure Scotland Act 1995 to the dates specified in Appendix 1 (excepting those where the accused is in custody)

The undernoted tables confirm the new dates assigned in criminal cases calling in Dumbarton Sheriff and JP Court in line with the Sheriff Principal's Order No 1 of 2020 for the period 25th March 2020 to 9th April 2020.
