### SHERIFFDOM OF SOUTH STRATHCLYDE, DUMFRIES AND GALLOWAY

#### COURT HOLIDAYS AND CUSTODY COURT ARRANGEMENTS 2020

I, **AISHA YAQOOB ANWAR**, Sheriff Principal of the Sheriffdom of South Strathclyde, Dumfries and Galloway, by virtue of the powers conferred upon me by Section 28(1) of the Courts Reform (Scotland) Act 2014 and Section 8(2) of the Criminal Procedure (Scotland) Act 1995, do **HEREBY** prescribe the following amendments to the Act of Court 2019, Number 1 and I direct as follows:

- (a) that there will be a sitting in Ayr Sheriff and Justice of the Peace Court on **Monday 7 September 2020** for the disposal of criminal business emanating from Dumfries and Stranraer Sheriff and Justice of the Peace Courts to deal with any person in custody;
- (b) that there will be a sitting in Dumfries Sheriff and Justice of the Peace Court on **Monday 21 September 2020** for the disposal of criminal business emanating from Ayr Sheriff and Justice of the Peace Court to deal with any person in custody;
- (c) that there will be a sitting in Airdrie Sheriff and Justice of the Peace Court on **Monday 28 September 2020** for the disposal of criminal business emanating from Airdrie and Lanark Sheriff and Justice of the Peace Courts and a sitting in Hamilton Sheriff and Justice of the Peace court for the disposal of criminal business emanating from that court, to deal with any person in custody;
- (d) that there will be a sitting in Dumfries Sheriff and Justice of the Peace Court on **Monday 12 October 2020** for the disposal of criminal business emanating from Ayr, Dumfries and Stranraer Sheriff and Justice of the Peace Courts to deal with any person in custody;

- (e) that there will be a sitting in Hamilton Sheriff and Justice of the Peace Court on **Monday 30 November 2020** for the disposal of criminal business emanating from Airdrie, Hamilton and Lanark Sheriff and Justice of the Peace Courts and a sitting in Dumfries Sheriff and Justice of the Peace Court for the disposal of criminal business emanating from Ayr, Dumfries and Stranraer Sheriff and Justice of the Peace Courts, to deal with any person in custody;
- (f) that there will be a sitting in Hamilton Sheriff and Justice of the Peace Court on **Sunday 27 December 2020** for the disposal of criminal business emanating from Airdrie, Hamilton and Lanark Sheriff and Justice of the Peace Courts and a sitting in Dumfries Sheriff and Justice of the Peace Court for the disposal of criminal business emanating from Ayr, Dumfries and Stranraer Sheriff and Justice of the Peace Courts, to deal with any person in custody;
- (g) that there will be a sitting in Hamilton Sheriff and Justice of the Peace Court on **Sunday 3 January 2021** for the disposal of criminal business emanating from Airdrie, Hamilton and Lanark Sheriff and Justice of the Peace Courts and a sitting in Dumfries Sheriff and Justice of the Peace Court for the disposal of criminal business emanating from Ayr, Dumfries and Stranraer Sheriff and Justice of the Peace Courts, to deal with any person in custody; and
- (h) that the public holiday custody courts due to take place on **Monday 28 December 2020** and **Saturday 2 January 2021** will no longer sit on those dates.

I appoint this Order to be inserted into the Act Books in every court within the Sheriffdom, published on the Notice Board of each court within the Sheriffdom and on the Scottish Court and Tribunals website.
