SHERIFFDOM OF SOUTH STRATHCLYDE, DUMFRIES AND GALLOWAY

AMENDED COURT HOLIDAYS AND CUSTODY COURT ARRANGEMENTS 2021

I, **AISHA YAQOOB ANWAR**, Sheriff Principal of the Sheriffdom of South Strathclyde, Dumfries and Galloway, by virtue of the powers conferred upon me by Section 28(1) of the Courts Reform (Scotland) Act 2014 and Section 8(2) of the Criminal Procedure (Scotland) Act 1995, do **HEREBY** prescribe:

- (a) those days specified in Column A of Schedule 1 attached to this Act of Court as Court holidays for those courts within the Sheriffdom specified in Column B of Schedule 1 in the period to January 2022; and
- (b) that there will be a sitting for the disposal of criminal business on those dates specified in Column A of Schedule 2 in those courts specified in Column B of Schedule 2 if necessary to deal with any person in custody in respect of criminal business emanating from the courts specified in Column C of Schedule 2.

I appoint this Order to be inserted into the Act Books in every court within the Sheriffdom, published on the Notice Board of each court within the Sheriffdom and on the Scottish Court and Tribunals website.

The order of 3 September 2020 is hereby revoked.
