



SHERIFFDOM OF SOUTH STRATHCLYDE DUMFRIES AND GALLOWAY

Order Refixing Diets: No 4 of 2021

in respect of Summary Sheriff Court Criminal Business in Hamilton Sheriff Court

In relation to the following categories of summary sheriff court criminal business calling on the dates specified in column A of each of the Schedules to this Order, certain diets have been assigned for dates which are no longer suitable to the court, namely:

- (i) All cases calling in the cited courts (except those in relation to which a letter pleading guilty or not guilty has been tendered);
- (ii) All cases calling in the intermediate diet courts except (i) those where the accused is in custody in relation to the case calling; and (ii) those in which a trial diet is fixed for a date on or after 1 March 2021; and
- (iii) All cases calling in the summary trials courts except (i) those where the accused is in custody in relation to the case calling; and (ii) part heard trials.


In accordance with the power set out in section 137ZB of the Criminal Procedure (Scotland) Act 1995, the court, of its own accord, hereby discharges each of the said diets assigned for the dates specified in column A of the Schedules to this Order and fixes new diets as follows:

1. In respect of all cases calling in the cited courts (except those in relation to which a letter pleading guilty or not guilty has been tendered) on the date specified in column A of Schedule 1 to this Order, a new diet will be fixed for the date set out in column B of the same row in the said Schedule;
2. In respect of all cases calling in the intermediate diet courts (except (i) those where an accused is in custody in relation to the case calling; and (ii) those where a trial diet is fixed for a date on or after 1 March 2021) on the date specified in column A of Schedule 2 to this Order, a new intermediate diet will be fixed for a date set out in column B of the same row in the said Schedule and a pre-intermediate diet meeting will be scheduled

- for a date set out in column C; the trial diet will also be discharged and a new trial diet will be fixed for a date set out in column D of the same row in the said Schedule;
3. In respect of all cases calling in the summary trials courts where an intermediate diet has been held pertaining to that trial prior to 12 January 2021 (except (i) those where the accused is in custody in relation to the case calling; and (ii) part heard trials) on a date specified in column A of Schedule 3 to this Order, a new intermediate diet will be fixed for the date in column B of the same row in the said Schedule and a pre-intermediate diet meeting will be scheduled for the date set out in column C; the trial diet will also be discharged and the new trial diet will be fixed for the date set out in column D of the same row in the said Schedule.
 4. In respect of all cases in which an accused person has a deferred sentence calling in the same court and on the same date as an intermediate diet or a trial diet which has been discharged by virtue of this Order, a new diet of deferred sentence will be fixed for the same day as the new intermediate diet or the new trial diet as the case may be.

Between 14 January 2021 and 26 February 2021 (both dates inclusive), all sentencing diets (except those referred to in paragraph 4 above) will call on the dates assigned. In respect of all cases calling for any other matter (such as a breach proof for a community payback order or a debate), except those in relation to which an accused is in custody, the case will call on the date assigned, the attendance of the accused will be excused and the case will be adjourned to a future date *ex proprio motu* without the need for representation on behalf of the accused.

The Sheriff Clerk is appointed to intimate said new diets to parties.
