



## **SHERIFFDOM OF SOUTH STRATHCLYDE DUMFRIES AND GALLOWAY**

### **Order Refixing Diets: No 7 of 2021**

#### **in respect of Justice of the Peace Court Criminal Business**

In relation to the following categories of business in each of the Justice of the Peace Courts calling on the dates specified in column A of each of the Schedules to this Order, certain diets have been assigned for dates which are no longer suitable to the court, namely:

- (i) All cases calling in the cited courts;
- (ii) All cases calling in the intermediate diet courts except those where the accused is in custody in relation to the case calling;
- (iii) All cases calling in the summary trials courts except those where the accused is in custody in relation to the case calling; and
- (iv) All cases calling for sentence (including mitigating circumstances and special reasons proofs) except those where the accused is in custody in relation to the case calling.

In accordance with the power set out in section 137ZB of the Criminal Procedure (Scotland) Act 1995 ("the 1995 Act"), the court, of its own accord, in respect of each Justice of the Peace Court in the Sheriffdom, hereby discharges each of the said diets assigned for the dates specified in column A of the Schedules to this Order and fixes new diets as follows:

1. In respect of all cases calling in the cited courts on the date specified in column A of Schedule 1 to this Order, a new diet will be fixed for the date set out in column B of the same row in the said Schedule;
2. In respect of all cases calling in the intermediate diet courts on a date specified in column A of Schedule 2 to this Order (except those where the accused is in custody in relation

- to the case calling) a new intermediate diet will be fixed for the date set out in column B of the same row in the said Schedule and the trial diet will also be discharged and a new trial diet will be fixed for a date set out in column C of the same row in the said Schedule;
3. In respect of all cases calling in the trials courts where an intermediate diet has been held pertaining to that trial prior to 12 January 2021, on a date specified in column A of Schedule 3 to this Order (except those where the accused is in custody in relation to the case calling) a new intermediate diet will be fixed for the date in column B of the same row in the said Schedule; the trial diet will also be discharged and a new trial diet will be fixed for the date set out in column C of the same row in the said Schedule.
  4. In respect of all cases in which an accused person has a deferred sentence calling in the same court and on the same date as an intermediate diet or a trial diet which has, by virtue of this Order been discharged, a new diet of deferred sentence will be fixed for the same day as the new intermediate diet or the new trial diet as the case may be.
  5. In respect of all cases (except those where an accused is in custody in relation to the case) calling for any miscellaneous matter other than a trial diet, intermediate diet or deferred sentence referred to in paragraph 4 above (such as a special reasons proof) on a date specified in column A of Schedule 4 to this Order, a new diet will be fixed for the date set out in column B of the same row in the said Schedule.

The Sheriff Clerk is appointed to intimate said new diets to parties.
